Overview

The 2007 Summer Conference will be held at the Jekyll Island Convention Center. The conference starts at 12:00 noon on Sunday, July 22. This year's event will address many issues within the field of prosecution. The conference will conclude at 12:00 noon Wednesday, July 25.

Registration

The registration fee is \$100.00 for employees of prosecution offices and \$150.00 for others. This conference is open to prosecutors, law enforcement and their staff. Please fill out and mail the registration form to PAC or fax to the Training Division at 404-969-0017. All registrations must be received by **Friday, July 6, 2007**. After this date, send registration form and increased fee to PAC. **NOTE:** after deadline, registration fee increases to \$150.00 for prosecution offices and \$200.00 for non-prosecution offices.

CLE

There will be a total of 14 general CLE hours available. The State Bar of Georgia's fee for CLE credits is \$5.00 per CLE credit hour. Professionalism hours are \$20.00. Please check your affidavit to make sure it contains the right amount for the credits you are claiming. When you mail your signed affidavit after the conference, make checks payable to PAC.

Reimbursement

The Prosecuting Attorneys' Council will reimburse those eligible at the following rates for lodging and meals. Meals will be reimbursed for actual expenditures or as follows, whichever is less: Breakfast \$7.00, Lunch \$9.00 and Dinner \$20.00. The maximum amount of reimbursement for lodging is \$115.00 per night. PAC will only reimburse for three (3) nights lodging. (**Special note:** If your office is 300 or more miles away from Jekyll Island, you may seek reimbursement for Saturday night. Attendees whose office or residence is located within a 35 mile radius of Jekyll Island will not be eligible for lodging reimbursement). In the event that a state vehicle is not available for your use, the reimbursement rate for mileage is \$0.485 . PAC DOES NOT reimburse for registration fees.

PAC Rule 6.10 (c): No reimbursement will be made if the individual fails to comply with the attendance policies of the sponsoring organization or if the individual fails to attend, without a valid excuse, 80% or more of the program scheduled for the time period for which reimbursement is sought. In order to receive your reimbursement, you must attach a Certificate of Attendance indicating the conference session(s) that you attend. To receive reimbursement for the entire 2007 Summer Conference, you must attend 11 hours of class.

PAC Rule 6.15 (b): Requests for reimbursement for travel expenses must be received by the Council on the appropriate form within 90 days of the expense being incurred. Requests for reimbursement that are submitted after 90 days will not be reimbursed.

PAC Policy 7.1(d): You can only be reimbursed by PAC for your expenses for attending one major PAC training program per fiscal year. The PAC major training programs are Summer Conference, Winter Conference, Spring Solicitor-General's Seminar, Key Personnel and the Investigator Conference. You may attend more than one major training program, but you will **not** be reimbursed by PAC for more than one program.

PAC Policy 7.1(f). You must be registered for the conference and pay the registration fee in order to be eligible for reimbursement.

Child Care

NO CHILDREN (REGARDLESS OF AGE) WILL BE ALLOWED IN THE LECTURE SESSIONS. Unfortunately, this year, the Prosecuting Attorneys' Council was unable to make arrangements to have child care at the convention center. Please make your child care arrangements before you arrive.

Parking

As many of you already know, there is a toll fee to enter Jekyll Island. The daily fee is \$3.00. This year, you may purchase toll passes in advance. There are two types of passes available: a 3-day pass for \$9.00 and a 7-day pass for \$21.00. The check must be received before they will mail the toll pass. **If you would like a mailed toll pass, Debra Wilkes must receive your request no later than June 22, 2007.**

Tax Exempt Form

Georgia Hotel and Motel Operators:

On April 12, 1987 Act No. 621 amending section 48-13-51 of the Georgia Code became effective. This act provides that Georgia state or local government officials or employees traveling on official business should not be charged county or municipal excise tax.

It is not considered to be the payment made directly by a state agency from appropriated funds. Upon verification of the identity of the state official or employee identified below, Georgia hotel and motel operators are authorized to exempt the individual from any applicable county or municipal lodging excise tax. Sales tax, however, should continue to be charged.
