Plan Changes for 2017

GaBreeze/Flexible Benefits

- True “OneUp” Special Enrollment for Life Insurance Plan.
- Cigna Dental Service expanded to 13 additional counties across the state
- 4% rate increase for Cigna Dental Plan
- Passive Enrollment with the exception of Flexible Spending Account (Healthcare and Dependent Care)

State Health Benefit Plan (SHBP)

- No Changes to Vendors and Pharmacy Benefits
- Slight rate increase on some plans
- Continued Services for Telemedicine/Virtual Visits
- Wellness Incentive Credits Rollover Continuance
- Children’s Hearing Aids Benefit Increase from \$3000 to \$6000

IMPORTANT Things to Remember for this 2017 Annual Enrollment

- Both GaBreeze and SHBP websites opens at 12:00 am on October 17th and closes at 11:59 pm on November 4th
- Print a copy of the confirmation page for your records
- Update or add dependents to applicable coverage
- Current 2016 elections will automatically rollover to the 2017 Plan Year with the exception of Flexible Spending Accounts (Dependent and Health Care)
- The Flexible Benefits “You Decide” Enrollment Booklet and State Health Benefit Plan (SHBP) Active Employee Health Plan Decision Guide are posted on each Annual Enrollment website as well as the PAC website.
